DRAFT HEALESVILLE STRUCTURE PLAN

- Your Input is Critical to the Future of this Region

This draft Healesville Structure Plan was released for public comment in December 2015. A Structure Plan is a critical document which determines future land-use policy for specific regions. It includes housing, transport, environmental protection, economic development and community services and so it is important for us all to register our interest and priorities in determining the future of Healesville. The development of the Structure Plan has involved two years of public meetings, local community surveys and a community reference group or steering committee. (HEWI was represented on this committee by Jeanette McRae). Studies on land use planning, economics, environment, transport/ parking and community infrastructure were prepared and contain valuable background information about Healesville. The draft makes some very positive strategic recommendations such as containing retail development in the town centre, improving cycling and pedestrian networks and increased environmental protection of riparian areas. There are also rezoning proposals for both inside and outside the Urban Growth Boundary which are of vital importance to the whole community. However, this Structure Plan will provide a template for the next 20 years and so it warrants a detailed by community members.

Council has endorsed six weeks of public consultation, commencing 1 Feb. 2016 and the document can be downloaded from Council's website, under Planning. A council planner will be available at the Community Link on Wednesday February 17, 10 am - 4 pm to assist residents and discuss the structure plan. There will also be a drop in meeting that evening. Although HEWI will make a formal submission, individual submissions are encouraged to ensure wide representation of your support and/or concerns.

FORESTS UPDATE

1. Murrindindi Council Motion passed on October 28, 2015

That Council:

i. Request MyForests Inc. to further their plans for the development of the Great Forest National Park

ii. Request meetings with the relevant State Government Ministers re progress on the GFNP

iii. Propose discussions with Yarra Ranges Council on the GFNP.

2. Friends of Leadbeater's Possum:

The emergency intervening planning group has looked at a new Recovery Plan for LBP. The new draft must be ready by the end of January to allow the required 3 months community consultation so that the Recovery Plan will ready by the middle of 2016 as stipulated by the Minister. Submissions are encouraged – check the FLBP website early Feb.

3. Forest industry Task force

There has only been one meeting and no chair has been appointed. Coupe deferral meetings have continued and there has been some agreement on 6 coupes but others were refused and/or deferred. The agreement to meet in early January was reneged as VF resources were diverted to actions taking place in East Gippsland.

4. KNOT demonstration in Healesville

Another striking display of their colourful banners at the Healesville gateway last weekend, to highlight the increasing number of loaded logging trucks driving through our town.
