WILDLIFE OF THE CENTRAL HIGHLANDS v VICFORESTS**Hearing Summary**

On Wednesday the 28th of January, WOTCH, represented by Environmental Justice Australia, took VicForests to the Supreme Court. The legal question is whether VicForests are unlawfully logging in the Central Highlands because of the recent loss of threatened species and key habitat in East Gippsland. The code of conduct which VicForests must comply with, states that they must take a precautionary approach to harvesting when risking environmental damage and impacting threatened species. Due to this summer's bushfires, many species such as the Greater Glider, Leadbeater's Possum and Powerful and Sooty Owls are now at greater risk of extinction. The importance of unburned habitat is therefore increased, though the exact ecological impacts of the fires have yet to be fully assessed.

The application that EJA filed on behalf of WOTCH, detailed 10 coupes that should not be logged as they provide habitat for listed species. An urgent second application was made a week later adding another five coupes. These applications effectively prevented VicForests logging in those coupes until the hearing on 18 February of the application for an Interlocutory injunction, which would remain in place until the case is resolved.

In court VicForests claimed that only 3 out of the 10 original coupes were currently active logging sites. The others were not planned to start harvesting for another 2 – 4 weeks. The Judge therefore ordered a temporary stay on logging in the 3 active coupes, with the others to be assessed in the scheduled hearing. After the hearing on 18th, Her Honour stated that she needed time to study the written submissions and consider her decision. She continued the interim injunction until further notice. At the time of writing, WOTCH are still waiting to be called back to court for the decision.

A decision is also awaited in the Federal Court case, Friends of Leadbeater's Possum v VicForests.

In a third case, the Victorian government has applied to the Supreme Court to reopen and broaden the case brought against it by Fauna and Flora Research Collective, which was heard in February 2019. After a mention last week, this application comes back to court in April.

Your HEWI committee continues to organise community activities that will hopefully engage others with a new aspect of our environment.... which may lead to an understanding of why we support urgent action by governments to reduce emissions NOW. We hope that members will access the on-line Summit recordings and respond to the emergency Declaration personally to provide the most powerful community message to our politicians.
