## Community Environment News

### POSITIVE CHANGES IN 2017 – Environment Victoria report

HEWI members have actively contributed to four of the following achievements and the Yarra River Protection (Wilip-gin Birrarung murron) **Act 2017** was another highlight.

#1 Victoria is leading the country on climate change  
Thanks to the Victorian community leading the way and standing up for our climate, our state has new climate change laws to cut pollution to zero. Now thousands of us are calling on the EPA to take the next step and limit emissions from big polluters.

#2 Together, we retired the oldest & dirtiest power station in the country  
After more than 10 years of community campaigning, Hazelwood closed.

#3 There was a flood of support for our Murray River

#4 The clean energy boom is coming

Thanks to community action, we have a new Victorian renewable energy target that will lead to a boom in clean energy. Solar powered trams, offshore wind farms... and #Repower groups are springing up in communities around the state. (*Healesville Community Renewable Energy, HCoRE, for instance!*)

#5 More than 25,000 of you acted on extinction

The new campaign for stronger nature laws in Victoria is gaining momentum with a large public forum, submissions to a review of the Flora & Fauna Guarantee Act and many petitions to the Minister.

(HEWI remains engaged in all these ecological issues, with detailed submissions re the native vegetation regulations, the protection of critically endangered fauna, especially both species of Leadbeater's Possum, Greater Gliders and Helmeted Honeyeaters and we are also involved with pest management, especially deer).

*All these positive outcomes achieved in 2017 will continue to require constant vigilance, actions and submissions from all of us.*

### THE LEADBEATER'S POSSUM REVIEW

– The Australian National University August 2017

The next 5-10 years will be critical for how the Central Highlands ash forests and the species that inhabit them persist (or otherwise) over the next century. This latest report is available and provides essential background for all Great Forest National Park supporters:

### HEALESVILLE SAFER TOGETHER BUSHFIRE WORKSHOP -
