As our contribution to CLIMATE CHANGE ACTION this month, we will show "Merchants of Doubt" – Naomi Oreske's film exposing the use of public relations tactics by tobacco companies and corporations to defend their businesses against scientific results that indicated dangers to health or the environment. These tactics frequently include the use of highly paid individuals discrediting well known scientific studies and were developed by the tobacco industry in the 1950s in response to evidence that smoking was a significant health risk. The film argues that these same tactics have been applied to forestall regulations of greenhouse gas emissions and to defend regulations requiring use of fire retardants in furniture.

Karen has already received more calls from interested neighbours and will arrange further meetings and inspections as required for registration with Melbourne Water's Streamside Management Program.

GREAT FOREST NATIONAL PARK - Council Agenda, October 13 HEWI has formally thanked Laurence Gaffney who raised two major issues at the last Yarra Ranges Environmental Advisory Committee that were then placed on this council agenda by Cr Len Cox. Item 11.1 concerned the apparent decline of *Banksia marginata* and Councillors approved a request to be made to the state government for a grant to cover monitoring of this species in Kurth Kiln.

Item 11.2 was more controversial – it proposed that an assessment be made about the costs and benefits of the Great Forest National Park and its impact on Yarra Ranges Council. The original recommendation was amended by Cr

McAllister and the final inclusive wording passed by 5 Councillors was: That 1. Council commission a report by an independent external consultant on the 'Great Forest National Park' proposal, including

(a) an assessment of the economic, social, cultural and environmental costs and benefits of the proposal for the Shire.

(b) recommendations regarding Yarra Ranges Council's position on the creation of the park.

(c) consultation with Murrindindi Shire Council 2. The report be prepared and presented to Councillors within 6 months

PLANNING APPLICATION FOR DEVELOPMENT OF THE OLD MILL SITE

HEWI has been making submissions on proposals for this prominent site the 'gateway to Healesville' since 2005. Last December, a new proposal was lodged with Council and by September 2015, the developers had managed to submit further information requested by Council back in January. There have been changes to the mix of businesses since the previous proposal that was approved by VCAT in 2013 but our objections remain the same - loss of amenity, indigenous vegetation and habitat; totally insufficient landscaping to prevent visual intrusion of buildings and car parking and complete lack of sensitivity to a site that overlooks our rural environs of the Yarra River valley and agricultural floodplains.

We urge all members to record their opposition to this current application YR-2015/1199 with Council as soon as possible. The files can be viewed at Healesville Community Link.
